#### Law and Rules

Nursing education programs seeking approval for program related changes must complete a Program Change Form. **Enrollment decrease** is a type of program change requiring prior notification to the NC Board of Nursing (NCBON).

If you have a planned decrease in enrollment, 21 NCAC 36 .0321 (I)(2) states:

- (I) The nursing education program shall notify the Board as least 30 days prior to implementation of:
  - (2) planned decrease in the Board-approved student enrollment number to accurately reflect program capacity.
