Rules and Accreditation Crosswalk

The Education Department developed a crosswalk to serve as a guide when comparing the NC Administrative Code (Rules) and National Nursing Accreditation Standards. The crosswalk is not an exclusive source of information from either the NC Administrative Code (Rules) or National Nursing Accreditation Body. Please note, all rules applicable to programs are not included in this crosswalk. For this reason, each program is strongly encouraged to conduct an independent assessment of NCBON regulations' applicability to individual program offerings regardless of National Nursing Accreditation Standards. This will ensure continued compliance with the established regulations. A copy of the Rules and Accreditation Crosswalk has been provided to program directors via email.

Annual Report

In collaboration with NCBON, the National Council of State Boards of Nursing assist with administering the Annual Report for pre-licensure nursing education programs. All program directors can access pertinent information located in the Resources and Downloads section of the Program Director Portal. Consistent with 21 NCAC 36 .0323(e), the Annual Report will be disseminated October 1. The submission due date is October 31.
